Need and Justification of the proposal keeping in view of NEP 2020 report submitted by the Deputy Educational Officer, Madanapalle :-

The school is located Kuravapalle village, Pothabolu post, Madanapalle Mandal, Annamayya District.AP., surrounded by Thurakapalle Village, Kuravapalle Village, Peddachinnaigaripalle Village, Pothabolu Village, Kothavaripalle village, Gandlapalle village, Palemkonda village, Enumalavapalle village, Bodumaladinne village and Kondamarrivandlapalle village.

There are 10 primary schools 01 High school nearby villages as detailed below in which there are 392 students in Primary classes, 136 students in the High School.

1. MPPS Thurakapalle which is at a distance of 3 Kms to the School.
2. MPPS Kuravapalle which is at a distance of 1 Kms to the School.
3. MPPS Peddachinnaigaripalle which is at a distance of 1 Kms from the School.
4. MPPS Kothavaripalle which is at a distance of 5 K.Ms.
5. MPPS Pothabolu which is at a distance of 2 KMs to the school

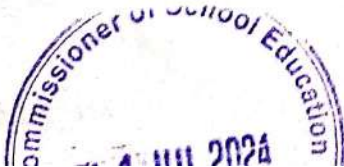
